1. Introduction

1.1. Recuperation of monies owed to Edinburgh Napier University Catering

Edinburgh Napier University is providing you with this information in order for us to comply with UK data protection legislation ("the legislation"), the General Data Protection Regulation: EU 2016-679 ("GDPR") and the UK Data Protection Act 2018 ("DPA 2018") as amended by "EU Exit" Regulations 2019 and now known as the UK GDPR, which requires us to tell you what we do with your personal information

2. Who is collecting the information?

Edinburgh Napier University as the "Data Controller".

3. Who are we sharing your Personal Data with?

The University undertakes to maintain your information securely and will restrict access to employees, our professional advisers, authorised agents and contractors on a strictly need to know basis. There may be circumstances where we are required to disclose your data to other external third parties, including where we:

- have serious cause for concern for your safety,
- are required to do so under a statutory or legal obligation, or
- are permitted to do so by Data Protection legislation.

4. Why are we collecting it/what we are doing with it (purposes)?

We are collecting this information for the recuperation of monies owed to Edinburgh Napier University catering during an IT system outage.

We will contact you via the email address provided to arrange payment. In the email you will be asked to return to the catering outlet to pay the outstanding monies with instructions provided on how to do this.

5. What is the legal basis for processing?

Art 6(1)(b), processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract;"

Please note that providing the personal data requested is necessary to complete the catering transaction for goods received whilst the catering tills are offline.

Failure to provide this information may result in your order not being processed.

We kindly ask for your cooperation in providing the required information to ensure a smooth and efficient experience.

7. What information are we collecting (whose information and what type of personal data)?

We will be collecting data from customers of Edinburgh Napier University Catering.

We will collect the following information types:

- Name
- Matriculation Number
- Amount spent

8. Who can see your information within the University?

Property & Facilities will have access to this information.

9. How long is your information kept?

No more than 10 working days.

Hardcopy/paper records will be store securely by Property & Facilities.
